Band Council Resolution

ORDER NO. 20-01-02

(Issued under By-Law No. 20-01 respecting COVID-19)

WHEREAS Atikameksheng Anishnawbek passed By-Law No. 20-01 indexed as the *Atikameksheng Anishnawbek COVID-19 Virus By-Law*;

WHEREAS section 6.2 of the *Atikameksheng Anishnawbek COVID-19 Virus By-Law* empowers Council or persons designated by Council to make orders with respect to matters which include regulating or prohibiting travel or movement by vehicle or by foot onto or off of the Reserve, evacuating individuals and animals and removing or relocating personal property from any area on the Reserve and arranging for the adequate care and protection of individuals, animals and property, and taking such other actions or implementing such other measures as the Council considers necessary in order to prevent, respond to or alleviate the effects of the COVID-19 virus;

WHEREAS local governments in Ontario have enacted social distancing measures to prevent the spread of the COVID-19 virus;

WHEREAS Atikameksheng Anishnawbek enacted Order No. 20-01-01 for the protection of the community, which included restrictions on travel onto the Reserve except for limited purposes;

WHEREAS it is desirable to lift restrictions on travel onto the Reserve set out at sections 11, 12, and 13 of Order No. 20-01-01 on a pilot basis while observing social distancing restrictions and monitoring community health;

AND THEREFORE IT IS RESOLVED THAT:

Short form of reference

1. This Resolution may be cited as the “*Specific Order Lifting Travel Restrictions*” and shall be deemed to be an Order for all purposes and within the meaning of the *Atikameksheng Anishnawbek COVID-19 Virus By-Law*.

Suspension of travel restrictions

2. The operation of sections 11, 12, and 13 (Limitation on travel) of Order No. 20-01-01 is hereby suspended.

Preventive measures remain in force

3. For greater certainty, nothing in section 2 of this Order modifies the other provisions of Order No. 20-01-01, including sections 6 and

7 (Limitations on gatherings), sections 8 and 9 (Mandatory self-isolation), section 10 (Mandatory social distancing), and section 14 (Powers of enforcement).
