DO HEREBY RESOLVE:

WHEREAS Atikameksheng Anishnawbek passed By-Law No. 20-01, indexed as the Atikameksheng Anishnawbek COVID-19 Virus By-Law;

WHEREAS section 4.1 of the *Atikameksheng Anishnawbek COVID-19 Virus By-Law* empowers Council by resolution to extend the State of Emergency for a period of up to 60 days;

WHEREAS the existing State of Emergency is scheduled to expire on May 29, 2020;

WHEREAS an election for Gimaa and Council is scheduled to occur on June 27, 2020;

AND WHEREAS it is desirable for the State of Emergency to be extended to cover the date of the election of Gimaa and Council and the transition period which will follow thereafter;

THEREFORE, BE IT RESOLVED

1. The State of Emergency declared pursuant to section 3.1 of the *Atikameksheng Anishnawbek COVID-19 Virus By-Law* is extended to Tuesday, July 28, 2020.
